

TERMS & CONDITIONS

1. INTRODUCTION

These Terms and Conditions ("Terms", "Terms and Conditions") govern your relationship with the **Wise** mobile application (the "Service") operated by **WiseApps ApS DBA of SSBeen ApS**. ("us", "we", or "our").

Please read these Terms and Conditions carefully before using our Wise mobile application (the "Service").

Your access to and use of the Service is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who access or use the Service. By accessing or using the Service you agree to be bound by these Terms. If you disagree with any part of the terms then you may not access the Service. The Service is available on mobile devices. Do not use the Service in a way that distracts you and prevents you from obeying traffic or safety laws.

2. PURCHASES
